#### **BACKGROUND**

The Company through its Managing Director/ Executive Director(s)/ Key Managerial Personnel or any other employee, as may be deemed expedient, who shall conduct programmes/ presentations periodically to familiarize the Independent Director(s) with the strategy, operations and functions of the Company.

Such programmes/ presentations shall provide an opportunity to the Independent Directors to interact with the Senior Management of the Company and help them to understand the Company's strategy, business model, operations, service and product offerings, markets, organization structure, finance, human resources, technology, quality, facilities and risk management and such other areas as may arise from time to time.

The programmes/presentations also familiarises the Independent Directors with their roles, rights and responsibilities as specified under the Companies Act, 2013 and Listing Regulations.

When a new Independent Director comes on the Board of the Company, a meeting is arranged with the Chairperson, Managing Director, Chief Financial Officer to discuss the functioning of the Board and the nature of the operations of the Company's business activities.

New Independent Directors shall be provided with the relevant copies of the Annual Report, the Code of Conduct, and the Code of Conduct for Prevention of Insider Trading and Code of Corporate Disclosure Practices, Schedule of upcoming Board and Committee meetings.
